

**SUBJECT:** Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for December 2019 (FY 2020) is \$3,286,629 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2020 proceeds total \$18,663,766, compared to \$22,121,159 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by January 31, 2020.
