SUBJECT: Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for June 2019 (FY 2019) is \$3,143,831 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2019 proceeds total \$43,109,939, compared to \$40,218,983 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by July 31, 2019.
